POSITION SUMMARY

The position of the Sexual Assault Nurse Examiner at Mosaic Georgia is a uniquely defined practice forensic clinician role within a free-standing sexual assault and Children’s Advocacy Center that provides comprehensive and multi-faceted “on-site” direct services of response and care to all persons victimized by sexual violence/ abuse and their non-offending family members. Defined services are inclusive of forensic medical assessment, examination and evidence collection for child, adolescent, and adult victims of sexual assault and/or child sexual abuse.

This unique SANE position receives a **competitive hourly on-call rate in lieu of an exam fee. Our on-call shifts are nights, weekends, and occasional holidays from 6am-6pm & 6pm-6am.** Mosaic Georgia P/T SANEs agree to **160 contracted hours per month.**

PRIMARY FUNCTIONS

This position is responsible for ensuring delivery of Forensic Medical Services when requested by law enforcement or adult non-reporting victims of sexual assault/abuse. This includes timely, accurate charting.

JOB RESPONSIBILITIES

- Ability to triage of the presenting patient(s) for the potential need for acute medical care •
- Perform and document sexual assault medical forensic exams accurately and timely •
- Perform a complete medical forensic evaluation to include:
 - Attain patients history of the assault
 - Head-to-toe medical assessment for trauma, detailed genital/anal examination o Forensic specimen collection and supportive documentation
 - Photo documentation of bodily and genital-anal injuries with competent documentation o Assess for mandatory reporting status and report when appropriate o Maintain chain of custody and adhere to evidence guidelines

- Ensure patient/medical record confidentiality at all times
- Maintain professional standards that do not create conflict of interests with employment or patient care
- Administer prophylactic medications and emergency contraception o Coordinate referrals for appropriate follow-up care as needed
- Testify as an expert witness to any/all cases performed while contracted as a SANE
 - Following employment/termination with Mosaic Georgia as a SANE, it will remain to be an obligation of the individual RN to respond and coordinate with attorneys prior to and during the court process.
- Commit to a minimum number of on-call shifts per month to include shared holiday coverage

MAINTENANCE OF SANE CREDENTIALS

- Participate in periodic case review to include documentation and photographs
- Maintain clinical education hours relevant to sexual assault, forensics, or pediatric subspecialty (minimum required hours 12 per calendar year)
- Membership in professional organizations, such as the International Association of Forensic Nurses strongly recommended
- Strongly recommend SANE-A/SANE-P certification
- Active email, and cell phone/text access for routine staff wide interface and communication

SANE QUALIFICATIONS

- Current Georgia Registered Nurse (RN) Licensure
- Individual malpractice insurance (1,000,000/6,000,000)
- 6-months of clinical/ direct patient care
- Completion of Adult/ Adolescent SANE didactic training (including all clinical requirements)
- Proficient use of all equipment
