24/7 CRISIS INTERVENTION & ADVOCACY

Mosaic Georgia provides 24/7 crisis intervention and advocacy services for victims by providing support through the process of disclosing or reporting abuse or assault, during medical exams, and through the judicial process. We also provide needed resources and assistance with next steps.

CHILDREN'S ADVOCACY CENTER

Mosaic Georgia's Children's Advocacy Center is a safe, child-focused environment for children who disclose sexual assault or abuse, or observed violence/abuse of another person. We provide children's forensic interviews, advocacy during acute and delayed exams, and court accompaniment. .

LEGAL ASSISTANCE

Directed by Mosaic Georgia's on-staff attorney, our legal advocacy services include assistance with legal information, resources, referrals, and/or direct representation, as availability allows, in civil matters resulting from sexual abuse or assault.

MEDICAL FORENSIC CARE

Mosaic Georgia's forensic medical care services include both acute and delayed forensic medical exams for all victims of sexual assault or sexual abuse. The exams are conducted by our staff of specially trained Sexual Assault Nurse Examiners (SANE).

EDUCATION & TRAINING

Mosaic Georgia offers prevention education services and professional training to local colleges, youth-serving organizations and others. Our educators and speakers are specially trained and knowledgeable about sexual assault and child sexual abuse, as well as how reported incidents are handled by the system, tips to support someone who discloses an assault and all services provided by Mosaic Georgia.

MENTAL HEALTH & WELLNESS

Mosaic Georgia provides trauma-focused counseling services to children and adults. clients can participate in individual, family and group sessions. Our Wholeness Collective is our trauma-informed healing and wellness program that offers "healing and wellness" activities such as healing arts, creative arts, movement arts, meditation and mindfulness classes and support groups.
